## Gift Received From Rogers Estate Impacts Three Local Organizations

At the beginning of the year, the foundation received a \$1.15 million gift from the estate of Martha Rogers, with an additional \$1 million promise to give pending a real estate sale.

With this generous gift, the Martha Rogers Fund was established. It was stipulated that the endowment's annual earnings be split between three local organizations: RISE, Inc., Habitat for Humanity of Northeastern Indiana, and Steuben County Council on Aging.
