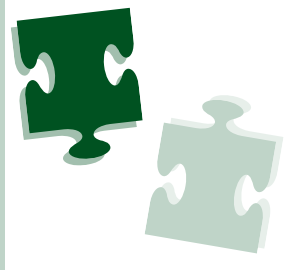

170 mile broadband fiber network owned and managed by Steuben County Community Foundation

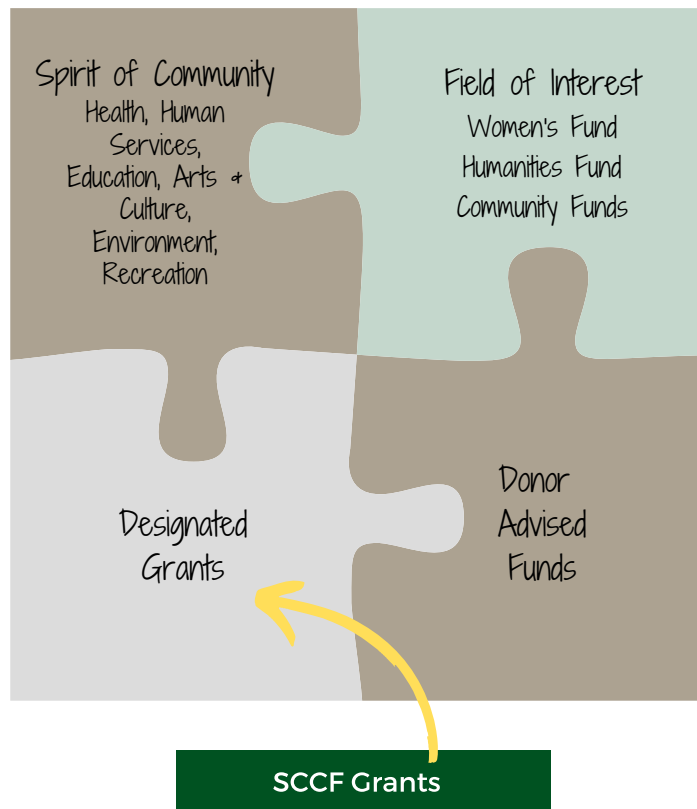
Providing low cost, reliable connections for 181 entities, including public school systems, libraries, government facilities, the local hospital system, and businesses in Steuben County

DESIGNATED FUNDS

SCCF awards grants to nonprofits and community projects from four different types of funds. Often, the grants that people are most familiar with are from our Spirit of Community fund, which supports projects that address human service needs, healthcare, education, art and culture, environment, and recreation.

In 2019, we're celebrating a corner piece of our grantmaking puzzle: designated grants. The following are a few of the funds that were established by donors to support the nonprofits they care about with grants that are automatically provided on an annual basis.



CJ & Bea Geiger Family Fund



The CJ and Bea Geiger Family Fund was established in Bea's memory by CJ in 2006 to support 10 charitable programs, including St. Paul's Chapel and Clear Lake Township Land Conservancy, as well as nonprofits in their home community of Defiance, Ohio.

Katie Oberlin Memorial Fund

In February 2018, the Katie Oberlin Memorial Fund was established to honor the spirit of Katie's passion for inclusion. This fund supports activities at RISE, Inc.



Dick & Fran Wilder Memorial Fund

The Dick and Fran Wilder Memorial Fund was established by their children in 2008 to provide support to the Charles McClue Reserve, Powers Church, Carnegie Public Library, Steuben County Historical Society, and First Congregational Church.



Every Child Included, Every Patient Included Funds

The Every Child Included Fund was established by Ms. Winifred Basset in 2002 to provide support to minor children in need of financial assistance to become a YMCA member, or participate in YMCA sponsored programs. The Every Patient Included Fund was established by Mrs. Winifred Basset in 2003 to provide direct support to hospice patients through Cameron Memorial Community Hospital.



Martha Rogers Fund



The Martha Rogers Fund was established by the Estate of Martha Rogers in 2013 to provide support to Habitat for Humanity, RISE Inc., and Steuben County Council on Aging.

Steuben County Historical Society Fund

The Steuben County Historical Society Fund was established by the Historical Society in 2000 to provide funding for administration and maintenance of their properties or to implement programs.



DESIGNATED FUNDS CONTINUED



SCCF has 95 designated funds which offer annual grants to more than 60 different nonprofits who serve Steuben County. These funds provide essential support for nonprofits. Some have been designated for operating use, allowing organizations to pay the electric bill and purchase supplies for clients. Others are for specific programs. All were established thanks to generous donors who wanted to leave a legacy, supporting their favorite causes even beyond their lifetime.
